We were treated very warmly even to the extent of being invited into a couple of homes where we were given fantastic meals. There was much dancing and drumming during the day.



In Denver, CO, it's hard to find a place to park your RV while visiting the Mile High City that doesn't cost a small fortune. We've found one!

It's the Jefferson County Fairgrounds, just west of Denver, near Golden, CO. It's located on U S Hwy 6, the exit is Indiana St. and is well marked with directions to the fairgrounds. The fairgrounds can be seen from the highway.

The cost is \$10/night with 30/50 amps, water is available and there are dumps near by. (They don't have a dump on fairgrounds at this time.)

What really makes this a neat place to park is there's plenty to do in the area, plus, there's lots of activity at the fairgrounds. We've been here a little over a week and had free entertainment everyday. The Westernaires Riding Club trains here (this is their headquarters). They workout everyday. When it DOES hurt to ask?

From The Wall Street Journal Sunday, August 10, 2003 (Sent by Paul Chamberlin)

Leaky rook? Stolen bike? Innocent inquiry?

You may want to think twice before even calling your insurance company.

Many home insurers count inquiry calls calls in which homeowners simply ask informally whether their policy will cover certain damages and are told that it won't--as unpaid losses. (Does this happen on all insurance questions--auto, health, etc.?)

Most insurance companies file loss information, paid or unpaid, into a centralized database called the Comprehensive Loss Underwriting Exchange, better known as CLUE.

Even if a policyholder just makes a phone call and doesn't report any damage, there's still a possibility the call will get logged into the CLUE report as an unpaid loss. This information stays on the record for five years, and can mar homeowner's chances of getting a standard policy next time they apply for insurance. (What else can this have an effect on?)

Travels with Roger and Brenda McFillen in Mexico

4 Mar

City tour- church of Guadalupe- three different churches, one modern and two older. 15 stations of the cross down here. All three structures are sinking as do all major structures in the city because it's built on an old lake bed that's never dried out. Most are less than six stories.

After the church we went to the Zocolo, or center city square. The plaza is the third largest in the world--church on one side, a palace and two government buildings. We toured some vendors around the square and side streets. Went into the church to cool off; a service was in progress. We got a tour of the choir semicircle, built into the center of the church along with two pipe organs. The organ they were using for the service was a very small electric one and the organist was singing the chants; at one point they sang Kum Ba Yah!!! We sang along from inside the choir spot!

We then went to the Museum of Anthropology. A most impressive courtyard structure you have to see to believe. I've got lots of pictures. Then we went to an indoor market with all the high class Mexican stuff. Got a table runner and a nice red shawl, very warm, but not wool. Last but not least we did a 30-minute stop at WalMart!

5 Mar

The Pyramids at Toihuacan - two very large pyramids built of solid rock and rubble, NO internal rooms. Called SUN and MOON, they are connected to the temple of Quetzalcoat by the Avenue of the Dead that has impressive rock carvings along the way. We climbed the Pyramid of the SUN, over 720 steps up and all above 8,000'. Stopped a few times on the way up. Great view and you could feel the presence of being in a holy place. Little is known about teh-oh-tee-wah-KAHN. These pyramids are among the most mysterious; very little is known about this religious center, the people that built it, or even what the city was originally called. The SUN that we climbed is five sloping levels over 250' high and the base measures 735' on each side. The MOON has a cluster of buildings surrounded by staired platforms and a square altar in the middle. MOON is 140' high, but appears as tall as SUN because it's built on higher ground.

The Temple of Quetzalcoati had the most impressive carvings and was built more like an amphitheater, with an impressive high stage/altar. All-in-all a fun day and we had to drive thru the city to get to it.

Thoughts on Mexico--many contrasts in many ways. They are probably 5-7 years ahead of the US in propane use for heat and in vehicles. The infrastructure is in place for vehicles. Hydrogen will be an easy switch for them. Fuel is government run and the prices are the same country wide. Diesel is less than gas, but more than propane. They have all the chain stuff we do and it tastes and looks the same but cheaper. They have a larger selection of new vehicles and options to choose from.

I wouldn't drive in Mexico City on a bet!!!! It's Italy times 10. Folks on the other bus saw a motorcyclist killed yesterday. We've seen lots of fender benders and a few major accidents on the side of the road or holding up traffic. The roads are fine, but little to NO shoulder. Toll roads are really nice and not that expensive. Traffic patterns are just weird and like nothing I've ever experienced. With more time on the road it will get easier.

Their sewer system doesn't take toilet paper, so you put it in a waste basket beside the pot. We have to do the same in the rig. RV tours that don't get the word have been known to plug up an entire park system.

Great bakery products and last night a man rode a tricycle into the park with an assortment of superb stuff. That's the good news. The bad news is it's only good for about 24-36 hrs. We had our laundry done yesterday--22.2 lbs for \$10. Nicely done, clean, soft, folded, buttoned and pressed.

7 Mar

We depart The City this morning. The rally was completed yesterday with a potluck breakfast, biz meeting and dinner at a very nice restaurant down town. We voted to go to the Copper Canyon next year, date not firm, but probably in March. Got the rig washed for 50P while I took a siesta. The dinner was superb with live seven-person band and seven course meal.

We have a group of 4 or 5 headed for Guanaunto, Guadalajara, Los Mochas and Guaymas coming out in Nogales. We'll probably leave the group in Los Mochas, leave the rig in a campground and take the train into the Copper Canyon. Remain over tonight to take a 4 WD trip into the bottom of the canyon to see villages where indians still live .

8 Mar

The drive to Guanajuato was one of the best so far. Started on 57, a toll road to 45 and then a little narrow back country road that is the REAL Mexico. We were in the mountains; superb vistas and a pleasant change from the smog and traffic of the city. In one small village we had to stop while a herd of goats crossed the road. Lots of burro's carrying loads of wood and goods.

Got to the campground around 1400, had lunch and set up. A lady in another group had gone to the back of their class A to take a nap while her husband drove. When they got to the campground he found her UNconscious in the corner of the bedroom. He got her up on the bed but she was having trouble breathing. We got her up on her feet and out to a recliner. A nurse in our group checked her out. Suspected concussion from a fall. She had a big knot on her head. A few hours after we arrived she was up and about and is touring in town today.

We had dinner at the campground restaurant. Nice food and presentation/service/with drinks, 75P/couple. I love this place The views from the campground are GREAT and you can see for 30 miles in all directions!

This morning we took the bus into town, 6P/couple. First stop Museo De La Alhondiga, 30P each. A huge building that started life as a grain storage facility, then a fort during the revolution and is now a museum. The town is an old silver mining area with so much history and landmarks that the entire town has been declared a National Heritage! It will take several days to see it all, and we're off to a great start.

Travels with Roger and Brenda McFillen in Mexico (Cont'd)

10 Mar

Guanajuato was a great place that we will visit again to see the mine and all the places we missed. Left camp a little before 9 and got here at 1430. Very nice site with full hookups, but the voltage is low.

The drive today was superb. Mostly "cuota" or toll roads, four lane divided. We drove thru pineapple country; rich red dirt just like Hawaii and agave, lots of it. Fact of the day: If the liquor made from the agave comes from Sinaloa, it's tequila. If it comes from any OTHER state in Mexico it must be called Mescal! and there are many grades/qualities of both.

Great views. Drove thru an ostrich ranch with lots of birds. Looked like the toll road just about split it in half. For those tracking our route, we took MX 45 - MX 80D -MX90D and the bypass around Guadalajara to MX15 (MX80), a little over 215 miles. We spent \$36 dollars on tolls and \$45 dollars in fuel. At the speeds these big class A's drive, 50-60 mph, we're getting 16 MPG!

We'll be here two days and then on to Mazatlan and Los Mouchas. After we got settled in camp we went to the World's Largest WalMart SuperCenter. Took some pictures--38 check out lanes! Had everything we needed except a battery for Brenda's watch, so for \$5 we got her a PINK digital that Courtney can use.

11 Mar Tlaquepaque

(Tiah-keh-pah-keh) A few minutes from Guadalajara's downtown. It is an artisan community that produces the greatest variety of artwork and handcrafts in Mexico. Restored old plazas on streets with big beautiful houses are now a lengthy pedestrian tourist area.

Lunch at the NO NAME cafe. Too typical to describe, but the pictures will explain. Peacocks wandered the dining area. Tortilla soup has become the standard we measure cafes/restaurants by. It was superb again today as was the main course. Cheese fondue was served in a lava rock aztec bowl in the form of some animal we've never seen.

The following day, 12 Mar, we headed for Mazatlan, a 300-mile trip thru the mountains. Great drive, \$45 worth of toll roads, but superb views. Some of it was like driving the Blue Ridge Parkway or Skyline Drive looking down into smoke/haze filled valleys. Saw lots of sugarcane and more agave.

We're down to a party of three and this morning we're NOT taking the toll road to Los Mouchs, we're going on the LIBRA! Will have to take some toll roads to get to the campground we're all meeting at tonight. All and Pat split off and we're headed to Copper Canyon with the Tirk's, Bob and Ann. Looking forward to a day on our own at our own pace where we can stop and see whatever we want!

13 March - Los Mouchis

We arrived here at 1530. Al and Bob took the Codia (toll rd) from Mazatlan, we took the Libra and got here 10 minutes after they arrived! Loved being on our own to stop and see whatever we wanted. Still spent 60P in tolls, one that didn't show on our NEW maps!

We're off to a new park 42 miles N of here tomorrow for a day of rest, laundry and make arrangements for our Copper Canyon visit via train. Mexico 15 all the way today. Not as scenic as yesterday, but saw some neat stuff. Great road, little to no traffic except in the towns. Speed limit most of the time was 80K. The trucks, buses and others were running 15-20 over that, so I just picked a truck or bus and followed it about 1/4 - 1/2 mile back and we averaged 82.4k for the time we were driving. Not bad for an old guy in a new truck. Love the way it handles the mountains, curves and hills. That Allison tranny is worth what I paid for it! The octane rating of diesel down here is 2-4 points higher than it is up north, so we're getting 16-17 MPG and it runs cooler on the hills. Fuel went up two cents, it's now 4.90P/lt; so it's still cheaper than what we were paying when we left.

It snowed more this afternoon and got colder while we visited a museum and did some shopping. Our room is nice and warm, but we froze our butts off walking a block to dinner. We only get 3 TV channels and they are all in Spanish, soooo it's time for bed. 0900 launch tomorrow!

21 Mar - Mexico Messages

We haven't been able to get PocketMail to work for the last 4 days, so we'll hold what's left till after we get across the border to some phones that work.

Nice weather here in El Fuerte. We paid for two more days and get a 7th for free, so we'll stay thru Fri and leave Sat the 22nd. Bob and Ann hooked into their neighbor's satellite system and we watched CNN this evening over beer and popcorn. Have heard there are long lines at the border, so we'll take our time and let them get their stuff together up there before we cross at Nogales; or we may just cool it up there for a while before we cross some time next week.

21 Mar - San Carlos

We're in the El Mirador RV park in San Carlos overlooking the Sea of Cortez. Great views and cafe. Will be here a few days. Nice digs.


